Jan 9, 1779 Hezekiah Jones sells Jacob Sessums 100ac on ES of Great Swp joins Cow Br. & head of a small branch. Wit: Nicholas & Solomon Sessums. Sampson-Duplin Deeds DBk 6 p294

Jun 30, 1779 Ezekiah Jones gets 150ac Warrant #958 & begins 300yds below his house on Beaverdam Swp. & runs up the Swp. - Bladen Co. Warrants & Grants Shuck #3864

Dec 23, 1779 Raman Adkinson sells Henry Jones of Halifax Co., NC 200ac, joins James Massey's corner, Manner, Beck, & George Bell, it being part of a Michael King Pat. Wit: David James, Thomas Ivey & Jonathan Tayloe Sampson-Duplin Deeds DBk 6 p455

Sep 25, 1781 Henry Lee sells James Spiller 100ac joins Stephen Blackman and Henry Jones Sampson-Duplin Deeds DBk 7 p264

Oct 12, 1781 Demsey Hollans sells James Spiller 40ac on Six Runs, a Grant to Thomas Amey, joins sd Spiller & Henry Jones - Sampson-Duplin Deeds DBk 7 p270

Jul 30, 1782 Joseph Hodges sells James Spiller two tracts of land on ES of Six Runs & Beaverdam. Wit: Nathan & Henry Jones . Sampson-Duplin Deeds DBk 7 p370

Jan 17, 1783 Peter Lee sells James Spiller 100ac on Six Runs, joins sd Spiller, Sampson Young & Henry Jones - Sampson-Duplin Deeds DBk 7 p421

Feb 4, 1791 James Spiller sells his daughters Ellen & Elizabeth Spiller several thousand ac on BS of Six Runs joins Nathan & Henry Jones & others. Sampson-Duplin Deeds DBk 8 p 356 & 357

Jan 11, 1792 Peter Huston enters a 100ac Grant on ES Great Cohary Cr. joins himself, John Fort, Joseph Williams & Nathen Jones - Sampson-Duplin Deeds DBk p

Oct 1, 1792 David James sells James Spiller 150ac on BS of Beaverdam, joins William Thompson, Henry Jones & Sd Spiller, lands formerly owned by George Bell. Wit: John Fort & C. Ealand James Sampson-Duplin Deeds DBk 9 p455

Feb 12, 1793 William Owens sells Jacob Sessums 40ac on WS of Little Cohary & BS of Beaverdam, joins Nathan & 200ac it being a Oct 18, 1787 Pat. to John Owens & joins Nathan Jones - Sampson-Duplin Deeds DBk 9 p64

Feb 13, 1793 Archabald Carraway sells Joseph Cartey 66ac on ES of Great Coharey & joins Nathan Jones. Sampson-Duplin Deeds DBk 9 p155

Dec 18, 1793 Roger Cutler leases Daniel Harrell & his wife Diana 100ac on WS of Six Runs it being land James Spiller purchased from Nathan Jones & others. Sampson-Duplin Deeds DBk 9 p456

Feb 8, 1794 James Spiller gifts his daud. Ellen Cutler & her son, my grandson James Spiller Cutler lands he got from Henry Jones & others. Sampson-Duplin Deeds DBk 9 p314

Oct 15, 1795 Shff. to Thomas Wiggins several tracts, one on ES of Great Coharey joins Peter Huston & Nathan Jones. Sampson-Duplin Deeds DBk 10p p162

Mar 8, 1797 James Spiller sells Edward Byrd several tracts on Six Runs & Beaverdam, joins Henry Jones & others. Sampson-Duplin Deeds DBk 10p p361

Aug 29, 1801 Marriage agreement btwn Henry Jones & Mary Bell - They agree to marry until one dies, at which time the holdings each brought into the marriage reverts to the children of their former husband & wife. Wit: Joel & Richard Johnson - Sampson-Duplin Deeds DBk 11 p487

Feb 3, 1802 Henry Jones sells Thomas Bell a negro woman named Jude & 2 children Landon & Abagale. Wit: David Clark Sampson-Duplin Deeds DBk 12 p33

Apr 5, 1802 Peter Mallett of Cumberland Co. sells Samuel Wm. Johnston several tracts of land ... 2nd tract of 100ac in Bladen Co. 1/4 mi above Mill on South Ri. which Peter Mallett purchased from Nathan Jones on Jul 9, 1801, which Nathan Jones purchased from Nicholas Sessums on Oct 26, 1795 (see Bladen Co. Jun 2, 1803 Thomas Davis gets a 100ac Warrant on SS of Beaverdam Cr. near the head of Hayles Horsepen Br. & joins himself and Hezekiah Jones. Bladen Co. Warrants & Grants Shuck #5742

May 10, 1807 Nathan Jones sells Levi Jones 100ac on SS of South Ri. on Watson's Br. Bladen Co. DBk 12 p120 & DBk 29 p119

May 30, 1808 Hugh Simpson got a 400ac Warrant #123 on NWS of South Ri. on SWS of Beaverdam Marsh joins Hezekiah Jones & Nathan Jones, John Simpson & Mrs Bryan - Bladen Co. Warrants & Grants Shuck #6162

Feb 8, 1809 Hezekiah Jones gets a 100ac Warrant #621 on NWS of Beaverdam Cr. joins Colemare Sessom, Archd. McDaniel, and himself & Nathan Jones. Bladen Co. Warrants & Grants Shuck #6310

Aug 15, 1800 Thomas Smith got Grant No. 2367 for 180ac on SS of Beaverdam, joins Griffith Jones. Bladen Co. DBk 7 p445

Jul 4, 1801 Nathan Jones sells Peter Mallott 100ac 1/4mi N of Mallott's dam on South Ri. land he got from Nicholas Sessums. - Bladen Co. DBk 27 p51

Dec 1, 1801 Hezekiah Jones pays for 550ac on WS of South Ri. joins his own land on Archer Pond. Bladen Co. Warrants & Grants Shuck #5651

Feb 10, 1832 John McDuffie & wife Mary J. sell Leavy Jones Lot No. 1 of Nathan Jones Estate on SS of South Ri. Wit: G. W. & R. Sr. Melvin & Owen Jones Bladen Co. DBk 10 p10

Aug 1, 1850 John Cain sells Margaret Ann Davis wife of Baxter Davis 50ac on WS of Turnbull, join Baxter Davis, it being Lot No. 1 of the Nathan Jones Estate drawn by John McDuffie in the right of his wife Mary & sold to John Cain. Bladen Co. DBk 28 p528
