**Alford-James T.** In-Private/Out-Private, Enlisted age 30 on September 4, 1861 for one year at White's Bridge-Camp Marion, near Georgetown, SC Sept. 4 to Oct. 31, 1861-Present; June 1862-absent sick; Nov./Dec. 1862-Discharged Nov. 21, 1862 at Tullahoma, TN-Certificate of Disability for Discharge-5'9" tall-dark complexion-grey eyes-dark hair-farmer-unfit for duty for 60 days-Nov. 8, 1862; Register of deceased soldier-widow Mary A. Alford-filed March 2, 1863-born Horry Dist.-**died Tullahoma, TN-Nov. 24, 1862 in hospital of disease.** Buried Confederate Section of Maplewood Cemetery, Tullahoma, TN (name on common plaque).

**Allen-W. P.** In-Private/Out-Corporal, Enlisted on September 4, 1861 for one year at White's Bridge-Camp Marion, near Georgetown, SC. Sept. 4 to Oct. 31, 1861-Present; Nov. 1862-Corporal-Nov. 3, 1862-Discharged at Bridgeport (TN)-age 44. No further.

**Anderson-Levi (David Levi)** In-Private/Out-Private, Enlisted age 19 on September 4, 1861 for one year at White's Bridge-Camp Marion, near Georgetown, SC. Sept. 4 to Oct. 31, 1861-Present; Nov/Dec. 1862 absent sick; CSA Post Hospital (St. Mary's) Dalton, GA-Admitted Dec. 23 or 28, 1862-Febris Typhoid (typhoid fever)-sent to hospital Atlanta Jan. 2-3, 1863; Jan./Feb. 1863 absent sick-sent off at Murfreesboro, TN Dec. 1862; March/April 1863 present; July/Aug. 1863 present; Sept./Oct. 1863 present; Nov./Dec. 1863 present; Jan./Feb. 1864 present; March/April 1864 present; Receipt for clothing 2Qr. 1864. Born Feb. 4, 1839 died July 22, 1921, buried Lewis Cemetery, Hwy 905, Horry County, SC.

**Anderson-T. J. (Thomas Jefferson)\*** In-Private/Out-Corporal, Enlisted age 26 on September 4, 1861 for one year at White's Bridge-Camp Marion, near Georgetown, SC. Sept. 4 to Oct. 31, 1861-Present; Nov./Dec. 1862 Corporal-present; Jan./Feb. 1863 Corporal-present; March/April 1863 4th Corporal-absent sent to hospital March 15, 1863 by order Surgeon Bailey; July/Aug. 1863 sent hospital 15 March surgeon Bailey; Sept./Oct. 1863 absent wounded Missionary Ridge (TN)-sent to hospital

Sept. 4 to Oct. 31, 1861-Present; Oct. 1862 sick at hospital; Nov. 1862 absent sick; Nov./Dec. 1862 absent sent to hospital from Tupelo (MS)-supposed to be dead. (Per CI Walker's book died of disease)

**Bailey-Solomon** Private; died May 23, 1863 at the Empire House Hospital, Atlanta, GA. Buried Confederate section of Oakland Cemetery, Atlanta, GA. Listed in the cemetery records as being in Company G, 10th SCl, also listed in find-a-grave. No further.

**Baker-W. L. (Willis)** In-Private/Out-Private, Enlisted age 25 on September 4, 1861 for one year at White's Bridge-Camp Marion, near Georgetown, SC. Sept. 4 to Oct. 31, 1861-Present; June 1862 absent sick; Oct. 1862 extra duty Teamster; Nov. 1862 extra duty Teamster; Nov./Dec. 1862 present; Jan./Feb. 1863 present; March/April 1863 present-extra duty ambulance drive(r) by order Col. Manigault; July/Aug 1863 present-extra duty as ambulance driver; Sept./Oct. 1863 present-extra duty as ambulance driver; Nov./Dec. 1863 present-extra duty as ambulance driver; Jan./Feb. 1864 present-extra duty as ambulance driver; March/April 1864 present-extra duty as ambulance driver by order Col. Pressly; On Roll of extra duty at 10th & 19th Regiment for

Oct. 1/Nov./Dec., 1862/Jan. 1, 1863/Apr./May./June/July/Aug./Sept./Oct./Nov./Dec. 1863 as a Teamster; Receipt for clothing 2Qr 1864; Paroled at Greensboro, NC on May 1, 1865.

**Barnhill-Joseph** In-Private/Out-Private, Enlisted age 29 on September 4, 1861 for one year at White's Bridge-Camp Marion, near Georgetown, SC. Sept. 4 to Oct. 31, 1861-Present; June 1862 **died of direa\_\_ (diphtheria?) Meridian, MS on June 25, 1862.** Buried, Confederate Mound-Rose Hill Cemetery, Meridian, MS.

**Barnhill-Josiah** In-Private/Out-Private, Enlisted age 37 on September 4, 1861 for one year at White's Bridge-Camp Marion, near Georgetown, SC. Sept. 4 to Oct. 31, 1861-Present; Certificate of Discharge-born Horry Dist.-age 39-5'8"-light complexion-blue eyes-light hair-farmer-unfit for duty past 60 days-dated Jan 31, 1862-signed by Sam. Bell Commanding, also signed by Col. Manigault and CI Walker Adjutant-March 12, 1862. Then enlisted Sept 2, 1863 Charleston in 1st Co. B, Manigault's SC Artillery as a Private/Private; Sept/Oct 1863 "since discharged". Father of W.T. Barnhill. (CI Walker's book has died)

**Barnhill-W. T. (William Turner)** In-Private/Out-Private, Enlisted Dec. 26, 1861 for one year at Camp Marion-by Col. Manigault-under Remarks: "Discharged Dec. 22-Final Statement given." Then enlisted Sept 2, 1863 Charleston in Co. B, Manigault's SC Artillery for the war as a Private/Private-present; Nov./Dec. 1863 present; Jan./Feb. 1864 present; March/April 1864 present; May/June 1864 present; July/Aug. 1864 present; Sept./Oct. 1864 present; Nov./Dec. 1864 present; Jan./Feb. 1865 present. Born May 8, 1845 died Sept. 25, 1915, son of Josiah & Narcissa Jones Barnhill, buried Beauty Spot Cemetery-Tatum, Marlboro County, SC.

**Bell-Samuel** In-1st Lieut/Out-Captain, joined for duty July 19, 1861 at White's Bridge-near Georgetown at the age of 37-in Company B - listed as absent; Aug 31, 1861 resigned as 1st Lieut. of Company B on Aug. 26, 1861. Enlisted age 37 on September 4, 1861 for one year as Captain of 2nd Company G - at White's Bridge-Camp Marion, near Georgetown, SC. Sept. 4 to Oct. 31, 1861-Present; Appointment Sept. 4, 1861 - "Dropped May, 8, 1862" (per Walker's Book he was not re-elected 1862); Voucher No. 17 paid June 11, 1862 from Feb. 28, 1862 to June 10, 1862 - \$433.33; Voucher No. 1176 paid Dec. 4, \_\_\_\_ - \$260.00; Letter in his records dated Dec. 9, 1860 at Conwayboro, SC to Gen. Gist-Cola., SC - asking for arms "The Brooks Guards (Co.B) are clamorous for arms, when can they be had?" written by 1st Lieut. Bell of the Brooks Guards; Voucher No. 179 paid Oct. 9, 1861 for Aug. 26, 1861 to Sept. 30, 1861 - \$147.22. Born Oct. 7, 1823 died Aug. 21, 1869; buried First United Methodist Church, Conway, SC.

**Benson-Jeremiah** In-Corporal/Out-Corporal, Enlisted age 44 on September 4, 1861 for one year at White's Bridge-Camp Marion, near Georgetown, SC. Sept. 4 to Oct. 31, 1861-Present. No further and not in Walker's book.

**Boon-Lazarus N.** In-Private/Out-Private, Enlisted age 24 on September 4, 1861 for one year at White's Bridge-Camp Marion, near Georgetown, SC. Sept. 4 to Oct. 31, 1861-Present; June 1862 on detached service; Nov. 1862 Teamster; Nov./Dec. 1862 present; Jan./Feb. 1863 present; March/April 1863 present-extra duty on daily service as Teamster; July/Aug. 1863 extra duty-Teamster; Sept./Oct. 1863 extra duty Teamster; Nov./Dec. 1863 extra duty-Teamster; Jan./Feb. 1864 extra duty-Teamster; March/April 1864 extra duty-Teamster; Receipt for clothing 2Qr. 1864; Paroled Greensboro, NC, May 1, 1865. (1 card under Lazarus W-see Lazarus N) (1 card under L. M.-see Lazarus N). Born ca. 1845 died after 1880, buried Old Strickland Cemetery, off hwy 266, Horry County, SC.

**Boyd-Daniel** In-Corporal/Out-Private, Enlisted age 22 as a Corporal on September 4, 1861 for one year at White's Bridge-Camp Marion, near Georgetown, SC. Sept. 4 to Oct. 31, 1861-Present; Oct. 1862 listed as deserted on regimental return; Nov. 1862 listed as a Private-deserted; Nov. 1862-Tullahoma, TN appears on consolidated report of deserters in the Reserve Division-1st Corps-Army of Miss. for last eight months. No further. Born Jan. 31, 1815, died Jan. 11, 1895, buried Cushion Swamp Cemetery, off Hwy 701, Horry County, SC.

**Boyd-Jesse** In-Corporal/Out-1st Sergeant, Enlisted age 26 as a Corporal on September 4, 1861 for one year at White's Bridge-Camp Marion, near Georgetown, SC. Sept. 4 to Oct. 31, 1861-Present; Nov./Dec. 1862-Sergeant-present; Jan./Feb. 1863 absent sick-wounded at Murfreesboro, TN, Dec. 31, 1862; March/April 1863-1st Sergeant- "absent-wounded at Battle of Murfreesboro sent to hospital at that place 31 Dec. 62"; Prisoner of War Dept. of the Cumberland-captured Stone's River; On list of prisoners who died while in Federal lines from Dec. 31, 1862 to March 1, 1863; "Cause of death Gun shot wound - died Feb. 10, 1863 at Murfreesboro." (Per Kirkland's book he died 1-26-1863)

**Boyd-John** In-Private/Out-Private, Enlisted age 21 on September 4, 1861 for one year at White's Bridge-Camp Marion, near Georgetown, SC. Sept. 4 to Oct. 31, 1861-Present; Oct. 1862 deserted; Nov. 1862 deserted. No further.

**Branton-Samuel P.** In-Private/Out-Private, Enlisted age 20 on September 4, 1861 for one year at White's Bridge-Camp Marion, near Georgetown, SC. Sept. 4 to Oct. 31, 1861-Present; Oct. 1862 sick at hospital; Nov. 1862 absent sick; Nov./Dec. 1862 present; Jan./Feb. 1863 absent on detached service-detailed at Murfreesboro, TN Dec. 1862; March/April 1863 absent detached on Engineer Corps Dec. 15, 1862 by order Gen. Polk; July/Aug. 1863 present; Sept./Oct. 1863 present; Nov./Dec. 1863 present; Jan./Feb. 1864 present; March/April 1864 present; Paid Jan. 27, 1863 \$22.00 for Oct. 31, 1862 to Dec. 31, 1862; Detailed Sappers & Miners-dated April 18, 1863; Receipt for clothing 2Qr. 1864. CI Walker's book has "Died". Kirkland's book KIA July 22, 1864 Atlanta.

**Cade-James S.** In-Private/Out-Private, Enlisted age 19 on September 4, 1861 for one year at White's Bridge-Camp Marion, near Georgetown, SC. Sept. 4 to Oct. 31, 1861-Present; Oct. 1862 deserted; Nov. 1862 deserted. No further.

**Cade-J. W.** In-Private/Out-Private, Enlisted age 23 on September 4, 1861 for one year at White's Bridge-Camp Marion, near Georgetown, SC. Sept. 4 to Oct. 31, 1861-Present; Register payments to discharged soldier-Discharged July 3, 1862-paid July 3, 1862 by JS Porcher. (age 74 when admitted to the Confederate Home on June 8, 1911.

Died of disease (Smallpox) at Rock Island Prison, IL on March 29, 1864, buried Rock Island Confederate Cemetery, IL.

Born 1835 died 1897, buried Poplar Methodist Church, Hwy 701, Horry County, SC.

**Chesnut-Daniel Henry** In-Private/Out-Private, Enlisted age 28 on September 4, 1861 for one year at White's Bridge-Camp Marion, near Georgetown, SC. Sept. 4 to Oct. 31, 1861-Present; June 1862 absent sick; Oct. 1862 in SC without leave; Nov. 1862 deserted; Appears on report of deserters in the Reserve Division-1st Corps Army of Miss. for past 8 months-dated Tullahoma,

TN-residence Conwayboro, SC. On list of paroled Confederate Prisoners captured and paroled by U.S. forces in KY in Sept./Oct./Nov. (1862)-declared exchanged at Camp Chattanooga, Jan. 11, 1863. March/April 1863 present; July/Aug. 1863 absent sent to hospital by surgeon Bailey May 13, 1863; Sept./Oct. 1863 absent sent to hospital by surgeon Bailey May 13, 1863; Nov./Dec. 1863 absent sent to hospital by surgeon Bailey May 13, 1863-since furloughed and expired Dec. 27, 1863-absent without leave; paid Nov. 20, 1863 \$44.00 for service from July 1, 1863 to Oct. 31, 1863. **Cook-Thomas J.** In-Private/Out-Private, Enlisted age 56 on September 4, 1861 for one year at White's Bridge-Camp Marion, 4 to Oct. 31, 1861-Present; June 1862 absent sick; Oct. 1862-died of disease (?Lyncrs?); low Eliza Cook-filed June 22, 1863-died Chattanooga, TN-amount due \$127.00; paid to Eliza

Cook widow, for service from March 1, 1862 to Sept. 30, 1862=7 months at \$11.00 per month=\$77.00 and six months clothing \$50.00-\$127.00 in all; died on or about Sept. 28, 1862. Believed to be buried in the Chattanooga Confederate Cemetery.

**Cox-Cornelius G.** In-Private/Out-Private, Enlisted age 14 on September 4, 1861 for one year at White's Bridge-Camp Marion, near Georgetown, SC. Sept. 4 to Oct. 31, 1861-Present; Nov. 3, 1862-Bridgeport-Remarks: "Discharged"; discharged Oct. 28, 1862-paid Nov. 4, 1862 by WL Wickham. Born Jan. \_\_, 1847 died March, 7, 1915, buried Oakwood Cemetery, Raleigh, NC.  
Has a VA stone in the Confederate section-grave 12.

**Dawsey-Daniel (Dausey)** In-Private/Out-Private, Enlisted age 34 on September 4, 1861 for one year at White's Bridge-Camp Marion, near Georgetown, SC. Sept. 4 to Oct. 31, 1861-Present; June 23, 1862 Columbus-died of disease; register of deceased soldiers from SC-died Corinth MS-reported Oct. 26, 1863-amount due \$44.43; Elizabeth J. Dausey widow-for pay for D. Dausey-1 month and 23 days pay-\$19.43 plus \$25.00 clothing (6 months)=total \$44.43. Card 17 has "died June 23, 1862 (disease)."  
Buried Friendship Cemetery, Columbus, MS.

**Doyle-Harrison L.** In-Private/Out-Sergeant, Enlisted age 26 on September 4, 1861 for one year at White's Bridge-Camp Marion, near Georgetown, SC. Sept. 4 to Oct. 31, 1861-Present; Nov./Dec. 1862-Sergeant-present; Jan./Feb. 1863 absent sick-wounded at Murfreesboro, TN Dec. 31, 1862; March/April 1862-2d Sergeant-wounded Battle of Murfreesboro Dec. 31, 1862-on furlough leave by surgeon to SC; July/Aug. 1863 absent without leave; Sept./Oct. 1863 deserted Jan. 1863; Nov./Dec. 1863 deserted Jan. 1863-furloughed and never returned. Born 1834 died ca. 1900, buried Bethlehem Baptist Church Cemetery, hwy 905, Horry County, SC.

**Edge Daniel M. (Murehinson)** In-Private/Out-Sergeant, Enlisted age 16 on September 4, 1861 for one year at White's Bridge-Camp Marion, near Georgetown, SC. Sept. 4 to Oct. 31, 1861-Present; June 1862 on guard duty; Nov./Dec. 1862 present; Jan./Feb. 1863 present; March/April 1863 present; July/Aug. 1863 present; Sept./Oct. 1863 present; Nov./Dec. 1863 absent-furloughed by "Army Hd" for 18 days Dec. 31, 1863; Jan./Feb. 1864 present; March/April 1864 listed as Sergeant-present-promoted to sergeant March 1, 1864 from private; receipt for clothing 2Qr 1864. Born March 6, 1845 died Feb. 22, 1911, buried Daniel Edge Cemetery hwy 90 & 31 (tombstone has "Rev."), wife Sarah Sophronia Patrick.

Application to the State of SC for artificial leg-right leg amputated below the knee-wounded Battle of Chickamauga Sept. 19, 1863. Confederate Pension application March 6, 1901-approved by City Examiners and pension board in 1889 for pension. His income did not exceed 200 and 50 dollars. VA tombstone at Edge Cemetery, hwy 90 & old hwy 90, Horry County, SC. His death certificate has that he is buried in the Royals Family Cemetery. (Maybe buried Chestnut Cemetery, hwy 905 and the stone removed to Edge Cemetery.) Born April 14, 1837, died March 17, 1917.

**Tompkins-Cornelius** In-Private/Out-Private, Enlisted age 21 on September 4, 1861 for one year at White's Bridge-Camp Marion, near Georgetown, SC. Sept. 4 to Oct. 31, 1861 present; Nov./Dec. 1862 present; Jan./Feb. 1863 present; March/April 1863 present; July/Aug. 1863 present; Sept./Oct. 1863 present; Nov./Dec. 1863 present; Jan./Feb. 1864 present; March/April 1864 present.

CI Walker's notes-wounded at Atlanta. Born ca. 1835, died 1913, wife Emma Allen, buried Juniper Bay Baptist Church Cemetery, Horry County, SC.

Marion, near Georgetown, SC. Sept. 4 to Oct. 31, 1861 present; Oct. 1862 furlough-time unknown; discharged Nov. 3, 1862 at Bridgeport; register of discharged soldiers-discharged (April 30, 1862?)-paid June 7, 1863 (62)-\$77.76 for May 1, 1862 to Oct. 28, 1862; discharge certificate: born Horry Dist.-age 17-5'7" tall-dark complexion-black eyes-black hair-farmer. Born c. 1845, died April 12, 1920, wife Mary, buried Poplar Methodist Church Cemetery, Horry County, SC. Brother of John and son of Philip and Jane Tompkins.

**Tompkins-John B.** In-Private/Out-Private, Enlisted age 18 on September 4, 1861 for one year at White's Bridge-Camp Marion, near Georgetown, SC. Sept. 4 to Oct. 31, 1861 present. CI Walker's book has "killed", Killed in Action on July 22 or 24, 1864 in Atlanta. Brother of David and son of Philip and Jane Tompkins.

**Tompkins-Samuel G.** In-Corporal/Out-Private, Enlisted age 24 on September 4, 1861 as a Corporal for one year at White's Bridge-Camp Marion, near Georgetown, SC. Sept. 4 to Oct. 31, 1861 absent on furlough Oct. 15, 1861 to Nov. 1861; June 1862 absent sick; Oct. 1862 sick at hospital; Nov. 1862 furloughed by surgeon; Nov./Dec. 1862-Private-absent without leave; Jan./Feb. 1863 absent at home on furlough; March/April 1863 present-due 3 months pay as corporal to May 31, 1862; July/Aug. 1863 present; Sept./Oct. 1863 killed at Chickamauga on Sept. 20, 1863- "wounded at Chickamauga Sept. 20-sent to hospital and died the next day on Sept. 21 (1863)"; register of deceased soldiers: widow Mary C. Tompkins (Margaret) -filed Dec. 2, 1863-died Battle of Chickamauga-amount found due \$130.46; 5'8" tall-dark complexion-dark eyes-dark hair-carpenter-due pay for 2 months and 20 days=\$29.33 and balance due for commutation for clothing drawn in kind \$101.46; paid Dec. 31, 1864 to widow.

**Tyler-Lewis** In-Private/Out-Private, Enlisted age 31 on September 4, 1861 for one year at White's Bridge-Camp Marion, near Georgetown, SC. Sept. 4 to Oct. 31, 1861 present; discharged May 24, 1862-paid Aug. 28, 1862 by NW Smith; paid \$30.80 on Aug. 28, 1862 for March 1, 1862 to May 24, 1862; born Horry Dist.-5'11" tall-age 35-light complexion-blue eyes-light hair-occupation Wheel Wright. Born Sept. 6, 1832, died March 7, 1899, wife Polly, buried Bayboro Baptist Church, Horry County, SC. Son of John G. and Penelope Tyler.

**Tyler-Moses** In-Private/Out-Private, Enlisted age 30 on September 4, 1861 for one year at White's Bridge-Camp Marion, near Georgetown, SC. Sept. 4 to Oct. 31, 1861 present; certificate of disability for discharge-unfit for duty-discharged on March 12, 1862-signed by Col. Manigault and Adjutant CI Walker. Born in Tabor City, NC in 1831, died Horry County, SC in 1864, wife Margaret King, son of John Jackson and Elizabeth Soles Tyler.

**Watts-Levi** In-Private/Out-Private, Enlisted age 25 on September 4, 1861 for one year at White's Bridge-Camp Marion, near Georgetown, SC. Sept. 4 to Oct. 31, 1861 present; no further. CI Walker's book has "died" (died of disease).

**Williams-Henry T.** In-Private/Out-Private, Enlisted age 22 on September 4, 1861 for one year at White's Bridge-Camp Marion, near Georgetown, SC. Sept. 4 to Oct. 31, 1861 present; Nov./Dec. 1862 killed in action at Battle of Murfreesboro, TN on Dec. 31, 1861; Register of deceased soldiers-wife Mary J. Williams-filed March 4, 1865-died "Battlefield". Believed to be buried Evergreen Cemetery-Confederate Section-unmarked grave, Murfreesboro, TN.
