THE SETTLEMENT OF SOUTH CAROLINA

As early as 1520, thirteen years after the death of Christopher Columbus, two spanish ships entered a wide bay on or near the coast of South Carolina. There they were greeted by friendly indians, who were invited to go aboard the ships, only to be trapped by the sailors who hoisted the sails and took to open sea before the indians could return to shore. One of these ships sank at sea and the other with its few native indians anchored at what is now Hati and sold its cargo as slaves.

In the year 1424, Giovanni Verranzano, a native of Florence Italy was sent across the atlantic by the King of France Francis I. He reached the coast of America at the mouth of the Cape Fear River and coasted thence fifty leagues in search of a harbor. In his report he discribes this area which was later known as South Carolina.

"The whole shore is covered with fine sand about fifteen feet thick, rising in the form of little hills about fifteen paces broad. Ascending farther we found several arms of the sea whick makes in through inlets washing the coast of both sided as the coast runs. There are immense forest of trees to various in color and too delightful and charming in appearance to discribe. They are adorned with palms, laurels, cypresses and other variety unknown to Eurothat send forth the sweetest fragrance to a great distance."

In the year 1663 and 1665, King Charles II of England gave eight of his friends the territory now known as South and North Carolina, Georgia and the Northern part of Florida. This area was known as Carolina and these Englishmer were called LORD PROPRIETORS of Carolina and were as follows:

Anthony Ashley Cooper
Lord Ashley, Earl of Clarendon
Sir John Colleton
The Duke of Albemarle
The Earl of Craven
Sir John, Lord of Berkeley
Sir William Berkeley
Sir George Cartrette

These proprietors set sail from England in 1669 on the ship Caroline, filled with immigrants. In April, 1670 they landed and began to build a fortification and houses on Albemarle Point on the west bank of the Ashley River. The settlement was called Charles town for King Charles.

THE INDIAN SETTLEMENTS

About 28 large families of indians in what is now the area of South Carolina. The Cherokecs on the Broad and Saluda Rivers, the Catawbas on the Wateree River and the Creeks in the region beyond the Savannah River. Near the side of the Ashley River dwelt the Kiawahs, the friendly indians to the early settlers. The kussoes furnished food but later became hostile. The Westoes, Yamassees, being infleuenced by the Spaniards at Port Royal, who furnished them with guns and hatchets attached the homes of the settlers on Pocataligo River and killed every man, woman and child they could find.

In the coastal area around Horry and Brunswick Counties and up into North Carolina were the Waccamaws and Wee hee Indians and along the Pee Dee River where most of the settlements took place, were the Pee Dee tribe.

In the autumn of 1665, a number of settlers from Barbadoes a settled on the banks of the Cape Fear River, near Wilmington and called their settlement Charlestown. By 1690n most of them had departed for other locations, but by this time there were names, North and South Carolina being used to distinguish the two settlements. Although these names were not set apart for these two settlements until 1729.

In 1711, the Tuscaroras, a cruel trible of indians fell on the North Carolina settlement and murdered more than two hundred. The people of South Carolina were quick to send assistance and Colonel John Barnwell with the South Carolina Riflemen helped drive the Tuscaronas back to their villiage on the Neuse River. This tribe suffered heavy casualties as later went to New York to join the Iroquois tribe.

In 1730, King George of England, realizing that little progress had been made in the province of Carolina for some time issued the following instructions to Govoner Robert Johnson of South Carolina.

"Whereas it has been found by long experience in our province of New Hampshire and Massachusetts Bay, that the settling of persons as were disposed to become planters, there hath redonnded were much to our advantage, not only with respect to the assistance they have been able to affort each other in their civil concerns, but likewise with regart to the Secutity they have thereby acquired the insults and incursions of the beighboring indians."

WHAT GAMES DID CHILDREN PLAY

One of the popular games your great grand parents played was "Hail Over" the house. The girls usually numbered the same as the boys and dashed around on one side of the house while the boys were on the other. The object was to throw the ball over the house and have the opposing team catch it before it hit the ground.

Baseball was played with paddles and a solid rubber india ball. The girls played and would catch the ball in their aprons. It was an interesting sight to see girls running in the fields with their aprons outstreached to catch a fly ball. Pitchers were called slingers and the batter was hit with the ball to be out.

Steal clothes: There were two sides, equally devided, a long line was drawn on the ground in front of each side and the boys jackets and the girls aprons were placed about thirty to forty yards behind each group. Anyone caught in the act of stealing or being pulled over the line was put into service on the opposite side. As soon as two were pulling each side linked behind their man and pulled like a tug o war, hugging the waist.

Another game was played with a home base and was called Fox and the Geese. One side was the geese and the other the fox. The fox would call, "Goosey Goosey Gander" the geese would answer "Fox in the manger" "How many geese you got" "More than you can catch in one haul" The last touch of home gave preference to catch.

Bull Pen: was played much like dodge a ball

Another game was played by placing the open hand against the house and letting another throw a ball at the palm from ten paces away. if he missed the open palm he had to take the place of the one he threw at and thus the new pitcher got a chance. The object was to go from one hand to another without missing.

Boys played Mumble Peg, with knives and girls played Jacks with sanded peach kernels, and Hop Scott. Marbles were played, with slippance, knuckle down, fire hard, no fudging, no clearance, no roundance, and no extention being the language used. When a man was hit he was considered dead and out of the ring. Each marble was named for its master.

OLD MEDICAL REMEDIES

Not many are yet aware of the old remedies that were used to dispell the major and minor illnesses of the old days. To some of the present generation, these might appear crude methods of curing desease, but many of our oresent medicines and drugs are made from the old receipes. I can remember when I was a young boy, my grandmother, who was the neighborhood doctor, used to make a tea from Boneset leaves and we were required to drink the tea for malaria. It was bitter like 666 and the same color. Can you remember the many poultice? Here are a few.

Mustard poultice, for conguestion, sprains, rhumatism etc. Poke root: used to put on tumors, remove them every 4 hrs. Charcoal poultice, take milk and bread or indian meal and half cup of charcoal, make a paste and put on bad sores. Slippery Elm Poultice, stire ground slippery elm bark in water and put on sores. Carrot: boil carrots, mash and use sweet oil to keep them from getting hard and put on sores. Onion poultice: same as carrot, used for boils. Then there was Lobelia poultice, arrowroot poultice and a poultice make from pulverized oats.

One of the old favorate remedies was: WILD CHERRY SYRUP, take two and half pounds of wild cherry bark, ground, to one gallon of water, steep this, drain and add enough sugar to make a syrup. Good for caugh and also a good body tonic.

Ointments: I guart of water and three handfuls of oak bark and apple tree bark, boil until water is reduced to one pint strain and add one half pound of hog lard, simmer until all the water is gone.

Saffron plants were used to cure scarlet fever, measles, chickenpox. a tea was made with the leaves.

Yellow goat beard supplied the leaves and bark from which a tea was made to check diarrhea. Hedge mustard was used to stop coughing. Dandelion root was used as laxitive.

Hedge nettle made a tea which was excellent for hemmorage internally. Penny royal to keep away mosquitoes. The milk from unripe poppy seed to kill pain. Dog fennel was used to cure colicn Wolfbane a powerful drug to kill pain.

/wood sorrel poultice was used for cancer. Lilly of the valley to release shortness of breath and heart trouble. Red berry trailing arbutus was used for kidney trouble. sage tea for sore throat, mustard seed to promote vomiting. Asparagus tea for free kidney flow: Garlic for whooping caugh, stomack troubles, convulsions. Horse radish for neuralgia and rhumatism.

THE FAMILY OF VAUGHT

The family spelling of the name VAUGHT seems to be on offshoot of the family of VOUGHT, Vogdt, Vogt, who were natives of Palatinate in Germany. A member of this family came to the Americas as one of a party of Lutherans headed by the Reverend Joshia Kockerthal, who left Germany and went to England in 1708 in order to petition the English Monarch, Queen Anne, to grant them a tract of land in the New World upon which to Colonize. Queen Anne was no doubt favorably impressed by their appearance of thrift and industriousness. At any rate the grant was made and in 1708 the first ship load of them came to this country. A second ship of them came just afterwards on the "Lyon" in 1710. and General Robert Hunter, newly appointed Governor of New York came on the same boat. The special tract of land granted by Qween Anne lay along the Hudson River near Newburg, New York, but Vought, called Simon Vought, one of these settlers having landed with the rest in New York City, preferred not to journey any further. He remained in the city for some time and later, in 1711, removed to western New Jersey, where he made his home in Middlesex and Hunterdon Counties. Simon and Christina Vought had the following children in this country. Johannes Christoffle, Margareta, Johnnes and Abraham. The oldest of these was known by his Anglacized name, John Christopher Vought and married Cornelia Putman, of the well known New York Dutch Family of that name. This explains the presence of the name Vaught, Vought in the New England Area until this day.

As too the beginning of the Horry County Vaught family, it would appear that original imigrant was one John Vaught, who with his wife came to this country in May, 1750. I quote for your information from a leter of the Honorable John D. Bellamy, Willmington, N. c. " My father, who was eighty years old when he died, and I am now seventy nine(1933) told me that Matthias Vought or Vaught came directly to that section from HANOVER, GERMANY. He was the father of Colonel Peter Vaught and Colonel Peter Vaught was a brother of my Fathers Mother." Peter W. Vaught, age 73, of Wellington Kansas, quoting a letter written by his father Anthony Sweet Vaught, says " (Written by his father) My Grandfather, Matthias Vaught was 10 days old when he landed at Charleston, S. C." This would indicate that Matthias Vaught, the elder son of John Vaught Senior was born at Sea while in route from Hanover Germany to this country.

John Vaught Senior, arrived in Charleston, around June, 10th, 1750 according to the letter of his Great Grandson, Anthony Sweet Vaught. He was evidently a a man of professional qualities for we find no record of his acquireing land until about nineteen years after his arrival. This land record is recorded in Royal Grants and gives date of 29th November 1770 and would have to be the record of John Vaught Senior for census records show the age of John Vaught Junior to have been under 15 years of age at this date.

ROYAL GRANT TO JOHN VAUGHT

South Carolina:

GEORGE the Third, by Grace of God, of Great Britian, France and Ireland, King, Defender of the Faith, and so forth, To All To Whom THESE PRESENTS Shall come: Greeting: KNOW YE THAT WE of our Special Grace, certain knowledge and mere Motion, have given and granted, and by these presents, for us our heirs and successors DO GIVE AND GRANT UNTO:

John Vaught his heirs and assigns, a plantation or tract of land containing:

TWO HUNDRED ACRES SITUATE IN CRAVEN COUNTY BETWEEN LUTTLE PEE DEE AND WACCAMAW BOUNDING SOUTH WESTWARDLY ON LAND LAID OUT TO JONATHON DRAKE ALL OTHER SIDES ON VACANT LAND.

and hath such shape, form and marks as appear by a plat thereof, herunto annexed: together with all woods, underwoods, timber and timbertrees, lakes ponds, fishings, waters, watercourses, profits commodities, appurtenances and hereitaments whatso ever, thereunto belonging or in anywise appertaining Together with privilege of hunting and hawking and fowling in and upon the same, and all mines menerals, whatsoever, saving and refering and reserving, never the less, to us our heirs and successors, all white pine trees, if any thereshould be found growing there on: and also saving and reserving, never the less to us our heirs and successours, one tenth part of mines of gold and silver only: TO HAVE AND TO HOLD the said tract of

of land, and all and singular other the premises here by granted unto the said:

JOHN VAUGHT

his heirs and assigns for ever, in free and common soccage, the said

JOHN VAUGHT, his heirs and assigns yielding and paying therefor unto us,

our heirs and successours, or to our Receiver-General for the time being, or to his Deputy or Deputies, for the time being, yearly, that is to say, on the twenty fifth day of March, in every year, at the rate of three shillings sterling or four shillings proclaimation money, for every hundred acres, and so in proportion accourding to the numbers of acres, contained herein, the same to commence at the expiration of two years from the date hereof, Provided always and this present Grant is upon condition never the less that the said:

JOHN VAUGHT

his heirs or assigns, shall and do yearly and every year after the date of these presents, clear and cultivate at the rate of three acres per hundred acres of land, and so in proportion according to the number of acres herein contained: and so shall and do enter a minute or docket of these our letters patent in the office of our Auditor General for the time being in our said province, within six months of the date hereof: and upon condition, that if the said rent, hereby reserved shall happen to be in arrear and unpaid for the space of three years from the time it shall become due, and no distress can be found on the said lands, tenements and hereditaments hereby granted, or if the said L

JOHN VAUGHT

his heirs or assigns shall neglect to clear and cultivate yearly and every year at the rate of three acres for every hundred acres of land, and so in proportion, according to the number of acres herein contained, or if a minute or docket of these our letters paten, shall not be entered in the office of our Auditor General for the time being, in our said province, within six months from the date here of, that then and in any of these cases, this present Grant shall sease and determine andbe utterly void; and the said lands tenements and hereditaments herw by granted, and every part and parcel thereof, shall revert to us, our heirs and successours, as fully and absolutely, as if the same had never been Granted.

In the above Grant, the only question that could arise is, "'Is this John Vaught Senior or John Vaught Junior, the younger brother of Matthias .?" In the census of 1800, John Vaught Junior is shown to be under age 45 and thus by easy subtraction, one could show his age to be under fifteen thirty years prior to 1800. Grants were not given to minors and this would rule out the possibility of John Junior being the recipient. Also, based on the fact that land was granted "fifty Acres per person in a family group," this would show the grantee to have three for which he was granted fifty acres each in addition to himself. It is reasonable to beleive that this Grantee was John Vaught senior, His wife, Matthias and John Vaught Junior. One year later, Matthias Vaught was granted 100 acres (age 21 in 1771) and this gives insight into his date of marriage to Mary Mercy Todd:

Based on these facts, let us begin to look at the Imigrant ancestor and his descendants.

-1-

John Vaught, Senior, born about the year 1725 as a native of Hanover Germany, married prior to his coming to this country. According to the records of his Great Grandson Anthony Sweet Vaught, he arrived in Charleston South Carolina around June 10th 1750, with his wife and young son Matthias Vaught, born May 31, 1750, about ten days out at sea from Charleston. John Vaught Senior must have been a professional man because no record is found of his owning land until his first grant in 1770. It would be reasonable to beleive that he spent his early years working and living in Chrlestown, where young John Vaught was born and schooled in Medicine. The name of his wife is not known to the writer, but it appears that his only children were:

- 2- MATTHIAS VAUGHT, born 5-31-1750, died 11-13-1833 Married:
 Mary Mercy Todd, daughter of Captain Charles Todd who imigrated to this country.
- 3- JOHN VAUGHT, JUNIOR, born about 1757, died 1809 married:
 Frances Moat, probably from Charleston, S. C.

THE WILL OF MATTHIAS VAUGHT, SENIOR

I, Matthias Vaught Senior of the District of Horry in the State Aforesaid, being weak of body but of sound mind and memory calling to mind the mortality of my body and knowing it is appointed to all men once to die, do make and ordain this my last will and Issiament-- My body I commit to the earth to be builted in a decent manner at the descretion of my executors--and as touching my worldly goods, wherein it has pleased God to bless me in this life with, I dispose of in the manner and form following:

+ I lend unto my dearly beloved wife, Martha, for and during the term of her natural life, but no longer, all my real and personal estate, saving and reserving the plantations whereon my two sons, Soloman and Peter now lives, Household and Kitchen Furniture, plantation tools, stock of hogs and cattle, horses and sheep, with all my redy money, books of accounts, subject to the conditions herein named, also the present crop for her use and present support and at her death to be disposed of as follows:

My negro Woman, Florah, to my daughter MARY PRICE, my negro woman Saray, to my daughter SARAH TODD, my negro woman Mariah, to my son SOLOMAN, with her future increase, my girl Dorinda with her future increase, to my son PETER, my negro man Will, to my son WILLIAM, MY NEGRO MAN JIM, TO MY SON JOSEPH, my negro man Aaron to my daughter E. BELLAMY, my boy Scipio to my daughter MARTHA DUNN, my negro man Cesear to my daughter REBECCA COX, my negro girl Betsy to my two grandchildren REBECCA AND JOSEPH TAYLOR. The above negros, bona fidily then remain the property of my children, thier heirs and assigns agreeable to the above statement --- It is my will and desire, that my two daughters, Mary Price . and Sarah Todd, do each receive out of my estate at thier mothers death, one Hundred Dollars in addition to the above negros and then all the residue of my property both real and personal be devided among my children share and share alike --- It is my will and desire that my two sons, Soloman and Peter have use of the plantations whereon they now live until the death of my wifes and I fall into the residurn and disposed of as aforesaid -- It is also my will and desire that if my estate during the lifetime of my wife should make more than will be sufficient for the support of my wife and my two Grandchildren, now living with us, that the overplus annually, or when ever it my accur be equally devided among my children.

It is the will and desire that my two Grandchildren Rebecca and Joseph Taylor live with my wife as long as she may live and receive such common education as it may be convenient during that time to give them or they may stand in need of--Lastly I hereby nominate and appoint my two sons, Peter and Joseph Vaught witness whereof I do nereunto put my hand and seal this fifteenth day of November in the year of our Lord, one thousand eight hundred and twenty eight.

MATTHIAS VAUGHT, SENIOR, born May 31, 1750, died November 13, 1833, was born at sea while his parents John Vaught Senior and his wife were in route to America from Hanover Germany. He was ten days old when his parents landed at Charlestown, South Carolina. Matthias Vaught, Senior married about the year 1771 to Miss Mary Mercy Todd, (Called by John D. Bellamy Mary Elizabeth) daughter of Captain Charles Todd. Mary Mercy Todd had brothers Richard, Soloman and Joseph and I am sure there were others. In the following letter, you will note that Matthias Vaught served in the Revolutionary War. This letter was written by John Dilliard Bellamy of Wilmington, N. C.

My father who was eighty years old when he died and I am now seventy nine (1933) told me that Matthias Vaught came directly to the Horry Section from Hanover Germany and his wife was named Mary Elizabeth Vaught. He was the father of Colonel Peter Vaught and Colonel Peter Vaught was a brother of my fathers mother. have often heard my father say that Colonel Vaught was a man of wealth and considerable influence, and while himself not a lawyer that he wrote all the deeds and conveyances in the Conway section, and owned a large plantation with a large nember of negros and that many of the old negro quarters, constructed of brick were existing in his day. Matthias Vaught who was my ancestor, was a patriot, and he was a member of Marion's Light Horse and fought in the Revolutionary War with Francis Marion at the Battle of Gwpens and got into a hand to hand conflict as a calvalryman with a member of Tarlton's English C Cavalry, and Matthias Vaught lost his leg and wore a wooden leg up to the time of his death, my father telling me that he frequently was with his grandfather and saw the wooden leg, and heard him marrate details of the conflict. If you will consult the records of South Carolina, you will see that the State granted him a pension for his part in the Revolutionary War. I do not know if he was a private or an officer in Marions light horse. Colonel Peter Vaught was a much richer man than his father Matthias. My father was himself an enormous slave holder and when he moved from the Horry Section of South Carolina and came to Wilmington in 1835, he brought seven Hundred and fifty negros and when the Civil War Broke out he was easily the richest man in North Carolina. I merely mention this as you seem to know nothing about the Vaughts and possibly it may be of some sinterest to you."

Matthias Vaught and his new wife settled on a plantation between Wampee and Red Bluff near what was known as Lee's Mill and in later years as Hardee's Mill.

3 Daughter of 2

Mary Vaught, the eldest child of Matthias and Mary Vaught, probably born about 1772-3, married Francis D. Price. He was probably born in North Carolina as no records were found for this family in Horry County records. The issue of this couple were not known.

4 Daughter of 2

Sarah Vaught, married Thomas D. Todd. Probably a Grandson of Thomas Todd, born 1735 and settling in the Wampee area of Horry County. I will speak of him later. No record is shown of this issue.

5 son of 2

Joseph Vaught, son of Matthias Vaught and Mary Mercy Todd, married Sarah Brantley. They lived for a short time, west of what is now Nixon's Cross Roads. Joseph Vaught owned a large acreage of land and was one of the leading citizens of HOrry County. He was also a member of the Board of Trustees of Old Cedar Creek Church, to which he deeded one half acre of land in 1840. He was a man of excellent business qualities, was executor with his brother Peter for his fathers estate. He was also given power of attorney by his sister, Elizabeth Bellamy and John Dillard Bellamy of Wilmington, to handle the estate of John Bellamy Senior. Joseph Vaught moved before 1850 to Florida where his children married. Issue by Joseph Vaught and Sarah Brantley was:

- Walter Vaught, who lived in Florida, nothing is found of his marriage or issue for this publica tion. It is presumed that he has descendants.
- 2. Harriett Vaught, who married Otho Haynes of Starke County Florida.
- 3. Isabella Vaught, who married a Haynes, probably a brother of Otho.
- 4. Armlain Vaught (Thought to be a child of Joseph. No data of his descendants.)

6 Daughter of 2

Elizabeth Vaught, born 1795, daughtter of Matthias Vaught and Mary Mercy Todd, married about 1814, John Bellamy Senior, born 1750, died 1826, son of John Bellamy and Sarah Frink. Her issue by this marriage was:

1. Dr. John Dilliard Bellamy, born 9-18-1817, died 8-31-1896, married Elizabeth McIlheny Harris 6-12-1839. She was born 8-6-1821. Dr. John Dilliard Bellamy removed from South Carolina to Wilmington, North Carolina to study medicine under Dr. William James Harris. In 1839 he was graduated with honors from Jefferson Medical College of the University of Pennsylvania and returned to Wilmington, North Carolina to begin his practice of medicine. Dr. John Dilliard Bellamy and Eliza McIlhenny Harriss had the following children.

Mary Elizabeth Bellamy, who married Williams J. Duffie of Columbia, S. C.; Marsden Bellamy, who became a prominent attormey of Wilmington, married Harriett Harlee of Mars Bluff, South Carolina; William James Harris Bellamy who married Mary W. Russell, and was a famous physician of Wilmington and Vicinity; Also Eliza and Ellen Bellamy who remained single. John Dilliard Bellamy, married Emma M. Hargrove, daughter of Colonel John Hargrove; George Bellamy, known as the "Duke of Brunswick" because of his political connections, married Kate Thees; Chesley Calhoun Bellamy, who never married, died in early manhood; Robert Rankin Bellamy, the youngest, was a very prominent druggist, he married Lilly Dale Hargrove a sister of Emma M. Hargrove. Dr. John Dilliard Bellamy bought the home of Governor Benjamin Smith in Wilmington, N. C. which was in itself a mansion to behold. It was built by Governor Smith in the peak of his career. He was a benefactor of the University of North Carolina having given the proceeds of twenty thousand acres of land in Tennessee for its Literary Fund. Yet Governor Smith died in poverty actually in prison bounds for debt, in Smithville (Now Southport) which was named in his honor. He was buried at night by torchlight in the Smithville grave yard to escape an alias writ. When Sheriff Leonard arrived the next day to serve the writ, Governor Smith had already been buried, and his body had become a part of the dust of the earth. The sheriff could serve no writ. It was no longer enforcible. Let me say in passing, that Governor Smith was brother of George Smith, Mrs William Dry, wife of the collector of the Port of Brunswick and Mrs R. Barnwell Rhett of Charleston. The Rhetts having no childred adopted George Smith and it was thus that he came to be known as R. Barnwell Rhett Jr.

2. Marsden Bellamy, son of Elizabseth Vaught and John Bellamy Senior was born May 25, 1824. He was a very studious young man and was on his way to attend the University of South Carolina when he was stricken and died in Marion, S. C. January 20, 1839. He was never married and was buried at the old Cedar Creek Cemetary at Little River, S. C.

These were the only children born to Elizabeth Vaught and John Bellamy Senior.

After the death of John Bellamy, Elizabeth Vaught Bellamy married Henry C. Williams born 1800. this marriage were born these known children. W. W. Williams, born 1832, B. M. Williams, Born 1834 Joseph H. Williams, born 1837, and E. R. Williams (F) born 1840. Recorded in the court house at Conway is: an agreement drawn between JOHN DILLIARD BELLAMY AND HENRY C. WILLIAMS that John Dilliard Bellamy agreed to pay Henry C. Williams, fifty dollars on signing the agreement, fifty dollars on thier arrival at Augusta Georgia, at which time he would supply the said Henry C. Williams with a train ticket to Macon Georgia, and fifty dollars for three months thereafter, if the said Henry C. Williams would agree to stay out of the State of South Carolina and away from Elizabeth Vaught Bellamy Williams. Reasons given was: Because of the worry and heart ache you have caused my mother."

7 son of 2

WILLIAM VAUGHT, son of Matthias Vaught and Mary Mercy Todd, married Mary Hankins, daughter of Dennis Hankins of Horry County, S. C. This couple moved to Florida where they are buried in the Laurel Hill Cemetary, on the Laurel Hill Plantation. Nothing was found of thier issue.

8 daughter of 2

MARTHA VAUGHT, born 1793, married John Dunn of Scotland who was born in 1774. Issue to the marriage was: William Vaught Dunn, born 1824 married Mary_____with issue known: Telatha Dunn: Charlotte Dunn born 1828, Francis M Dunn, born 1829 and John W. Dunn born 1840(Circi). Many of the descendants of this family still live in North Carolina.

9 daughter of 2

Charlotte Vaught married about the year 1823, David Taylor, of North Carolina. This union did not last many years before the death of Charlotte. The issue of these children are known: Joseph Taylor, who married Catherine Giles, daughter of Hugh Giles and Lenora Davis Giles: Rebecca Taylor who married James Baker, son of William Baker and Annis Phillips Giles. Joseph Taylor and Catherine Giles resided near South Island, in Georgetown County, S. C. Thier children were: Hugh Giles Taylor, who married Ella McClelland: Joseph E. Taylor, Edwin E. Taylor, Archie Taylor, Charlotte Talor, who married a Cobb, and Sallie Taylor.

Rebecca Taylor, daughter of Charlotte Vaught and David Taylor, married James Baker, son of William Baker and Annis Phillips Giles. James Baker had a sister Mary Baker, who married Gospero Sweet, son of Anthony Sweet, who was Great Grand Uncle of "Margaret Mitchell of "Gone with the Wind". Thier children: Joseph Baker who married first Mary J. Graham and secondly Anna Graham. William Baker, who married Martha Tennant and secondly, a widow by the name "Mrs China": James R. Baker, who married Mary Monroe.

Joseph A. Baker, son of Rebecca Taylor and James Baker, married Mary J. Graham and had James G. Baker, who married Annie Monroe: Joseph M. Baker who married Annie Gaddy.

Joseph A. Baker, married secondly: Anna M. Graham, and had issue: Doctor Mary Baker, who married Dr. R. G. Blackburn(she was one of the early women doctors.. thier son R. G. Blackburn resides near Centenary Highway, Marion County, S. C.): Marion Taylor Baker, married Miss Wrightson, They had one daughter. He was mayor of Manning, S. C. in 1915.

William W. Baker, who married Martha Tennant, had issue: James Oscar Baker, John Tennant Baker, Warren Caldwell Baker, ,Mary Baker and Lilliam Baker.

William W. Baker married secondly the Widow China and had issue: Judge David Gordon Baker, who married Julia Badger and lived in Florence. Thier son Gordon Badger Baker was also Judge of the twelth Judical Circuit of South Carolina.

James M. Baker, who married Mary Monroe. Thier issue was The late Robert Baker of Cenenary and three other sons.

REBECCA VAUGHT, daughter of Matthias Vaught and Mary Mercy Todd, married Captain Peter Cox, son of Captain Josiah Cox of Cox's Ferry. Josiah Cox was in Captain Moses Pearson's Company, 1780-1782. Thier children were: Charlotte A. Cox, who married C. W. Brock, James A. Cox, John H. Cox who married Martha Ann Pettie Wall, daughter of Washington Bradley Wall and Mary Sweet Vaught. (Daughter of Peter Vaught): Charles w. Cox, Sarah E. Cox who married a Graham and moved to Texas and a daughter who married a Reaves and had issue: Sarah E. Reaves, John H. Reaves, Rebecca C. Reaves and Martha M. Reaves....

John H. Cox, son of Rebecca Vaught and Captain Peter Cox, married Mary Ann Pettie Wall, born 6-9-1845, died 11-14-1917, who was the daughter of Mary Sweet Vaught and Washington Bradley Wall. Thier children were: a. John Cox, who died young b. Peter Cox who married Missouri E. Bessent.

Peter Cox, son of John H. Cox and Mary Ann Pettie Wall born 2-13-1870, died 4-27-1911, married Missouri E. Bessent, born 3-5-1875, died 5-4-1911, and had issue: Victor Sloan Cox, who married Mary Louise Arnold, Alma Beatrice Cox, who married Rona C. Permenter, Claude Cox, who died young, J. Marion Cox who married Zuleen Hardee, J. Bertram Cox who married Mildred Daniels, and Mesburt Cox, who is unmarried and in San Francisco, California.

Captain Victor Sloan Cox, born 1896, died 1960, married mzry Louise Arnold of South Port, N. C. daughter of Joseph N. Arnold, Cape Fear River Pilott. Thier son Victor Earl Cox married Louise Bryan and secondly Cecil A. Causey. Alma Beatrice Cox, born 9-9-1899, died 12 16-1942, married Rona C. Permenter. Thier children are, Jack Permenter, who married a Hardee,: Jane Permenter who married an Inman: Mary Eleen Permenter who married Eldrige Hickman.

PETER VAUGHT, son of Matthias Vaught and Mary Mercy Todd, born 5-30-1774, died 11-1867. He lived on a plantation near his father, between Wampee and Red Bluff during the early years of his marriage. He served as sheriff of Horry County, a member of the Congress and carried the honorary title of Colonel Peter Vaught.

"I have often heard my father say that Colonel Vaught was a man of wealth and considerable infleuence, and while he was not a lawyer that he wrote all the deeds and conveyances in the Conway Section, and owned a large plantation with a large number of negroes and that the old slave quarters, constructed of brick were existing in his day." (John D. Bellamy)

Peter Vaught was also a teacher in the River Planter school. He did not serve in the War between the States but was concerned about the yankee ships shelling the minerals Salt Manufacturing Company along the shore and requested protection by the conferderate forces.

Peter Vaught married first Miss Mary Sweet, daughter of Anthony Sweet II, by whom he had six children.

a. Peter Vaught, Junior, son of Peter Vaught Senior and Mary Sweet, married first, Joemma Harrell, two children were born to this marriage: Cornelia and Ellen Vaught.

Peter Vaught Jr. married secondly Louise (Cukon) Futch and had issue: William H. Vaught, Della Vaught who married and Elk, Annie Vaught who married a Roach and died in Illinois.

- b. Anthony Sweet Vaught, son of Peter Vaught and Mary Sweet, married Anna Disdale, after moving to Kansas. He died there on July 4, 1898, at Hollenberg, Kansas. His wife, Anna was born in 1844 and died 1931. Eight children were born to the couple. Peter W. Vaught, of Wellington Mansas, H. M. Vaught of Wallawa, Ore. A. G. Vaught, Powell Wyoming, John M. Vaught, Tocoma Washington and a daughter, Mrs J. C. (Emma) Day of Omaha Nebraska. Peter W. Vaught was 73 in 1935.
- c. Waites Alson Vaught, the third child of Peter Vaught and Mary Sweet has no record to be found.
- d. Mary Sweet Vaught married First Washington Bradley Wall son of Wright Wall and Mary Bradley. Thier children were: Peter Wright Wall who married Addie P. Randall and secondly: Mary C. Lee: Martha Ann Pettie Wall who married John H. Cox: Babriella Bradley Wall who married Leonard R. Owens. George W. Wall who married Mary Gertrude Cwens and married secondly Mary Caroline Lucy Lupo, Columbus Wall, Sarah Wall who married Henry Shaw of Marion County, (Elizabeth SHAW married William Godbold, son of Eli Godbold, thier son A. Bradley Shaw received an education at the Citadel. He married first Margaret Vereen, daughter of Joseph Dewitt Vereen and Ann Waller and married secondly Alma Van Landingham Cellon of Florida.)

 Amanda Wall married Barney Collins and lived at McCall South Carolina. Elizabeth Wall married Charles Cox and lived at Horry County, S. C.

Mary Sweet Vaught Wall, married secondly George Soloman Jordon. Thier children were: Ellen Vaught Jordon who married William Chesley Kerce of Gainsville, Florida John G. Jordon married Nora Atkinson. (Their son Myron Glenn Jordon died in World War II). Gause S. Jordon, and Emory Claudius Jordon who married Anna Corine Sweet, born 3-31-1859 died 8-14-1948: (Their children were: Wilson Jordon who married Hessey Gibson of Spartanburg: Daisy L. Waller, born 3-2-1840, died 9-19-1842: Peter Rebecca Waller, born 4-2-1844, died 11-7-1846, Ann Vereen: Peter Vaught Waller, born 1-12-1846 and married Joseph Dewitt Sweet Waller, born 6-12-1850 married Benjamin Blanch W. They resided at Little River, she was the daughter of Giles and Elizabeth Smith Lee of Horry County. Their only daughter was Dalma Wall who married J. B.

Gabriella Bradley Wall, daughter of of Mary Sweet Vaught and Washington Bradley Wall, born 8-26-1856 died 3-27-1919, married 6-11-1872, Leonard R. Owens who was born 1-16-1850, died 10-14-1909. He was a descendant of Colonel Thomas Dew of the London Company one of the early settlers and burgessess in Virginia in 1635, through Sarah Dew who married Steven Berry, Gabriella Bradley Wall's revolutionary war ancestor was Leiut. Wright Wall who married Mary Bradley.

In 1819, Frances Moat Vaught his wife died leaving an aggreement with Thomas Ready for her children. "Private, L. Company, 7th regiment, S. C. Infantry, inlisted, 6-21-1861 at Conwayboro, S. C. under Captain W. C. White. On roll October 31, 1862 as in hands of the enemy. On Roll April 31, 1864 as absent, sick since March 1, 1864. On Roll June 30, 1864 as absent, wounded since return. He was wounded also September 13, 1862 at Maryland Heights.

The following are records made by Shadrack Vaught of his memory of the Confederate War.

" We the Horry Volunteers as we were called, met in Conway on the 24th day of June, 1861. Captain W. C. White in command of the Company. At noon a good dinner was served with pleasure, under the big live oak trees in front of the Methodist Church, after which a thrilling address was delivered by Elder Betts and aged Preacher. We were then marched off amidst waving handkerchielfs and a roar of cannon. We were conveyed to Cool Springs by carts, wagons and buggies and there bivowacked that night. next day we were conveyed to Marion Court House and on the 26th were mustered in service by Colonel Miles. that evening for Wilmington, N. C. The next morning we left for Petersburg Virginia, spent the night there. next morning we went on to Richmond where we stopped a We left there on the 30th of June for day or two. Manassas Junktion Virginia and bivowacked that night. July 1st we marched out through Fairfax Villiage, the County seat. In about one mile we met the 7th S. C. Regiment to which we had been assigned as Company L.

The 7th regiment was commanded by by Colonel Bacon and belonged to Brigadier General W. L. Bonhams Brigade. The second regiment under the Colonel J. B. Kershaw, the 3rd regiment under Colonel J. D. Nance, and the 8th regiment under Colonel E. B. C. Cash. Each regiment membered about 1000 rank and file and belonged to the army of Northern Virginia. At this place we drilled and did camp duty. the morning of the 16th of July, W. A. Dusenbury G. A. Dusenbury, Wilson Edge and myself were detailed for picket duty. This was my first time on picket. Our post was about 23 miles south west of Washington D. C. stationed at a fine well of water. We were kindly entertained by 3 ladies of the place with biscuits and butte; lite loaf and buttermilk. The next morning after sunrise, our joys ceased when we saw the long dark lines of blue coats and glittering muskets coming over the hill. The yankee army under General Scott was now on we four boys. As we left the yard the advance guard fired acannon at us. it only cut down a fine cedar tree in Mr. Spears yard. We arrived in camp in time to join our company and fall back across Bull Run Creek where our army made a final stand the next day. There was some skirmishing. all worked with a will making a tempory breast work as best we could on Sunday, the 21st. The ball opened sure heavy fighting right, left and in front about 3 oclock that evening. Bonhams brigade was ordered to the front and out we went doublequick, made good every order, captured a fine fattery, four cannon, with large piles of knapsacks, cooking utensils and C, also a few prisoners. Thus the Federal army was completely routed in full retreat for Washington. The confederates had achieved a grand victory at the first battle of Manassas.

On Monday morning, we pursued the retreating army to Falls Church, a little Villiage, eight miles south west of Washington. Our army then dropped back a few miles, went in quarters and went to drilling in ernest. The 7th regiment camped at Flint Hill and used water from Mr. Spears good well where some of us had had our first picket experience. We remained at flint Hill until September, where G. W. Ward and myself were taken sick, and sent to Chimboraze Hospital at Richmond, Virginia. It was here we first met Dr. R. C. Carlisle and learned to love him. We were transfered to Manchester Hospital just across the James River. Here we had the attention of Doctor Bissel, Doctor F. L. Parker and his brother Doctor John Parker. We were duly returned to camp, went into winter quarters on Bull Run Creek where we spent most of the winter ending our first years campaign.

About the time we broke winter quarters, several of the regiment had yellow Jaundice and was sont to the hornital at Charlottesville, Virginia. David Rabon, Joseph Hucks and myself were together under charge of Dr. Thompson at this place. I first met Dr. T. G. Teague here.

The University of Virginia is situate in this beautiful little town in the centre of the old Dominion. Near by is the Jefferson Mountain and the Monticello, both beautiful to look at. P. V. Cox, Captain G. T. Litchfield and myself while here visited the residence of President Thomas Jefferson. This Albermarle County was the centre of the State they told us. When we started back to camp a wreck accurred about nine miles south of Hanover Courthouse. We boys undertook to walk to Hanover and took a soaking rain on the way. We stopped with a good Samaritan who with his kind family cared for us that night showed us his quinea pigs and white rabbits.

When we arrived at town, Peter Cox had a high fever. doctor detailed me to help nurse our sick comrade, but he lived but a few days and died about evening. Longstreets corps was ordered to the Peninsula about 75 miles east of Doctor Clifton sent me back to Chimboraso with Richmond. W. F. Singleton and W. H. Hardee to wait for the Kershaws Brigalde. They passed at night and we followed the next day. We joined our company below Williamsburg where we waited reenforcements. The approach of McClellans army by water one évening about the first of May. The 7th wa The 7th was ordered on picket duty. We marched in slow rain until dark, We were ordered to build piles of brush that had been cut previously and fire the brush. The regiment formed hastily I moved at quick step silently our fine lights got a heavy shelling but burned nothing. Only two of Company L reached camp that night. Leuit. G. T. Litchfield, H. J. Barnhill and myself took refuge in an old Black Smith Shop. We could not have fire, rather a bad place to sleep however we enjoyed our stay in the old shop and all got in safely the next morning, no one hurt. We all had a laugh at our indian caper and was ready for the next. I think it was on the 3rd of May the regiment was ordered to bring up fence rails. They were oak, dedar and chestnut. We piled them and set fire. They made a fine light. Lees army must now fall back to Richmond and as we took up our line of march, Kershaws Brigade was rear guard. We marched all ni night as we entered Williamsburg, McClellans Advance picket guard overtook us and opened up a brisk cannonade. On hasty orders, the 7th regiment about faced, doublequick and the black horse artillary was going back full speed on the muddy street to check the advance. As we filed right and formed line of battle, one of the 8th regiment had his head shot off at our side. All the boys had got amused at Major Scibles awkward command some other amusing incidents occured amidst the bursting shells and long range bullets.

We held our ground until night, for we had over 500 magons in the city, the quartermaster said. I think he saved then all. We moved on covering that long line of wagons and artillary. I think that General Barkdales Mississippi Brigade releived us next morning. There was but little fighting on that long march. Think we were on that March until the last of May suffering extremely for rations, as the commissary wagons were necessarily kept well to the front, six or seven miles a day, being all that army could make. It halted about six miles east of Richmond and the 7th reorgan ized. "

" Judge John Samuel Vaught, dean of the Horry County officeholders will on August 12, celebrate his eighty second birthday and at the end of his present term of Probate Judge of the "Independent Republic" he will have served a quarter of a century in this capacity. His health is excellent and he loses no time from his work. Born and reared on a farm in the Simpson Creek section of the county , Judge Vaught had little opportunity for schooling as the confederate War had practically closed all schools and when the war was over he was obliged to spend his time working,

Just when he bacame interested in politics he does not recall it must have been many years ago as he servered as magistrate at Conway before holding his present office and at one time came very near being the county supervisor, the successful candidate leading him by a scant margin.

On January loth, 1935 the following appeared in the Horry County Paper...

J. S. VAUGHT HAS PASSED: Dead after a long and useful official life in Horry.

" Judge J. S. Vaught passed away at his home in Conway, surrounded by his children and intimate friends, at tem oclock on last Tuesday, January 8th.

He was going into his eighty-fourth year and until the latter part of December, 1934, he was regularly at his office at attending to his usual duties as Judge of the Probate Court of Horry County. After having served as magistrate for a number of terms at Conway he was elected Judge of Probate about twenty four years ago! Thus he was elected and served out six full terms in that office. At the time of his death he had just served out the last of the six terms and his successor was being qualified to take his place. Judge Vaught was a remarkable man in various ways Quiet and unassuming yet he was a quick thinker and he was consulted almost daily by those needing advice, not only in a legal or estate matters but on other and unrelated affairs of life. He was the great friend of widows and orphans, never failing to give his time where it was needed and also giving of his means so far as he was able. He will be missed by a large following of friends all over the county. "
